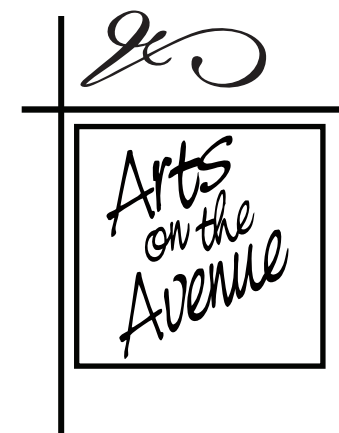

- Complete and return entry form on or before Saturday, April 14th, 2012
- Include two samples which represent your product line. (These will be used for sampling by the jurors)
- Provide a written explanation detailing the process used to make your products along with an artist statement.
- All specialty foods exhibitors must adhere to the regulations as set by the Vancouver Island Health Authority and be prepared to provide documentation if requested.
- Cheque or money order for fee made payable to Arts on the Avenue.
- Samples and application forms can be mailed to or dropped off on or before April 14th, 2012

- Please include a list of products that you will be selling during the event. Please note that all products for sale must be created by the artisan.

### CANCELLATION POLICY:

Cancellation deadline is August 1, 2012 for accepted artists  
Cancellations prior to July 20, 2012 will receive full refund less \$15.00 administration fee.  
Cancellations after August 2, 2012 forfeit entire registration fee.

***All entries will be handled with care. However, festival organizers shall bear no responsibility or liability for loss or damage to submissions.***

### JURY PROCESS

- Applications will be judged on quality, originality, variety, and aesthetic qualities.

## Criteria:

- All work must represent the artist's original design. Any work created from a commercial pattern, kit or template will **NOT** be accepted.
- ***Artists may only display and sell work of the same style and quality that has been accepted by the jury.***
- Exhibitors must supply own:
  - ✓ 10x10 Tent
  - ✓ All necessary display and equipment needed for the event.
  - ✓ Weights for your tent.
